Amnesty International is concerned for the safety of Thelma de Lam, the newly appointed *Fiscal Especial para los Defensores de los Derechos Humanos*, Special Prosecutor for Human Rights Defenders and for Marines Martínez, one of her assistant Special Prosecutors, who have both been the subject of death threats and harassment in the last two weeks.

On 20 June, three armed men entered the house of Marines Martínez, in the capital, Guatemala City, and demanded to see her. After one of the domestic servants told the men that she was not at home, they told her to tell Marines "if you carry on with your investigations, you're going to get a surprise tonight" ('si siguiera investigando va a recibir una sorpresa esta noche').

On the same day, unknown men attempted to enter Thelma de Lam's house in Guatemala City. They claimed to be electricians and insisted threateningly that they needed to have access to the house in order to mend a fault. However, no fault had been reported. As a result, the men were refused access and they left shortly afterwards.

On 23 June, Thelma de Lam received two anonymous calls on her mobile phone. The first caller told her "you should be careful with what you're doing" ('Tuviera cuidado con lo que esta haciendo"), and the second caller told her to stop her work with the Ministerio Público (MP), Public Prosecutors Office ('termine su trabajo con el Ministerio Público').

# **BACKGROUND INFORMATION**

Thelma de Lam was appointed as Special Prosecutor for Human Rights Defenders in May 2003. The unit is mandated by the Guatemalan state to investigate crimes carried out against human rights activists. The previous Special Prosecutor in the unit, Tatiana Morales Valdizón, was also subject to death threats and harassment. Investigations into this case are still ongoing (See UA 26/03, 27 January 2003, AMR 34/003/2003).

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- urging the authorities to offer immediate protection to Thelma de Lam and Marines Martínez from the Fiscalía Especial para los Defensores de los Derechos Humanos (MP), Office of the Special Prosecutor for Human Rights Defenders;
- calling on the authorities to carry out an immediate, exhaustive and impartial investigation into these incidents and to make the results public;
- urging the authorities to support publicly the state-mandated work of the Special Prosecutor's Office for Human Rights Defenders.
