UA 215/93 "Disappearance" 28 June 1993

Amnesty International is concerned about the "disappearance" of Erwin Alvarado Estrada and Aurelio Cabrera Méndez on 24 June 1993 in the municipality of Joyabaj, department of El Quiché, which is heavily patrolled by members of the Patrullas de Autodefensa Civil (PAC), Civil Defence Patrols.

According to reports, on 19 June 1993 the two men were attacked and threatened with being shot by the head of the PAC in that area. Later that day they were followed by the same man, who shot at their homes and at their vehicle. On the following day, while the two men were at the local police station asking for protection, another member of the PAC arrived at the police station and apparently said, in the presence of police officers, that "the job had not been done properly" and that he would do it himself. The police reportedly tried to detain him but he escaped.

Subsequently, on 24 June 1993 Erwin Alvarado Estrada and Aurelio Cabrera Méndez "disappeared" following a meeting with the local governor of the department of El Quiché.

Erwin Alvarado Estrada and Aurelio Cabrera Méndez had refused to join the PAC and had been actively trying to bring members of the PAC to trial for alleged violations. For this reason, it is feared that they may have been detained. However, this has not been acknowledged by the authorities and there is therefore concern for their safety.

BACKGROUND INFORMATION

Civil Defence Patrols (PAC) were created as a component of the military's counter-insurgency strategy in 1982. Although voluntary according to the Constitution, civil patrols are in effect compulsory. Those refusing to take part in them have been branded "guerrillas", and many have been subjected to human rights violations, including harassment and attacks, "disappearance" and extrajudicial execution.

On 6 June 1993 Ramiro de León Carpio, previously the Human Rights Procurator, was voted President by Congress, following his near-unanimous selection by Congress to serve out the remaining term of President Jorge Serrano Elías. Ex-president Serrano had been forced from office after trying to seize near-dictatorial powers.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in Spanish or in your own language:

- expressing concern about the "disappearance" of Erwin Alvarado Estrada and Aurelio Cabrera Méndez;
 - asking for an immediate investigation into their whereabouts;
- urging that, if held in detention, they be humanely treated and granted access to a lawyer, doctor and relatives;
- urging that, if held in detention, they be promptly brought before a competent court or else released.
