HAITI: Sulfrid Jeune EXIMÉ (student)

Amnesty International is concerned that Sulfrid Jeune Eximé, a secondary school student, was reportedly arrested without a warrant on the evening of 25 April 1992 in Gros-Morne, Artibonite Department.

According to information received by Amnesty International, Sulfrid Jeune Eximé is accused of distributing leaflets in favour of the deposed President Jean Bertrand Aristide. He has reportedly not been formally charged nor has he been brought before a court. He was initially taken to the military detachment in Gros-Morne, and was subsequently transferred to the prison in Gonaïves.

Amnesty International has received numerous reports of prisoners being ill-treated upon arrest and in custody. Although no information has emerged about Sulfrid Jeune Eximé's treatment, in view of such reports Amnesty International is concerned for his physical safety.

## BACKGROUND INFORMATION

Troops violently overthrew the democratically elected government of President Jean-Bertrand Aristide, who took office in Haiti on 7 February 1991, in a coup on the night of 29 to 30 September. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests without warrant. These abuses have been carried out by uniformed security force agents or, on some occasions, by men in civilian clothes ostensibly linked to them.

Students and others who are real or perceived supporters of President Aristide have been consistently targeted by the armed forces. On 12 November 1991, following a meeting of the <u>Féderation nationale des étudiants haïtiens</u> (FENETH), National Federation of Haitian Students, inside the premises of the Science School of the State University of Haiti in Port-au-Prince, more than 100 students were reportedly arrested and several others severely beaten by members of the Armed Forces. Students from Sulfrid Jeune Eximé's neighbourhood are reported to refuse to attend school in protest at his arrest and sources in Gonaïves report an increased tension between the students and the local authorities.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/airmail letters (apparently some mail is now getting through to Haiti, so please do send letters):

- expressing concern at the reported arrest without warrant of Sulfrid Jeune Eximé;
- asking that unless charged with a recognizably criminal offence, he be immediately

- asking for guarantees that his physical integrity be respected while in custody.
