Further Information on UA 36/03 (AMR 41/005/2003, 7 February 2003) and follow-up (AMR 41/008/2003, 20 February 2003) - Fear for safety/possible abduction

Erika Abigail Loera Varela, who was reported missing on 20 December 2002 in Ciudad Juárez, Chihuahua State, has been found and is safe and well. Amnesty International is however, concerned for the safety of both Viviana Rayas who went missing on 16 March 2003 and Marixela Ortíz Rivera, who was reportedly subjected to acts of intimidation and harassment following her work as a human rights defender.

Sixteen year old Viviana Rayas was reportedly last seen on 16 March 2003 in the City of Chihuahua, Chihuahua State. Prior to going missing, she had been with a study group of school students carrying out a school assignment. At 5.30 pm she left to take the bus home, but never arrived. Viviana's parents, friends and colleagues searched for her, but were unable to locate her. A report was lodged with the *Procuraduría General de Justicia de Estado de Chihuahua*, (PGJE), Chihuahua State Prosecutor's Office. Despite the case being reported as abduction, the authorities allegedly do not consider there to be sufficient grounds to investigate it on this basis. At present, Viviana's family have not been given any information about the progress of the enquiry.

Viviana is the eighth young woman to go missing in the City of Chihuahua since December 2002. In 2002, a young woman called Paloma Anglica Escobar Ledesma went missing in the city. A month later she was found dead near to the main road to Ciudad Juarez, the other major city of the state. She had been raped and tortured. Since 1993 scores of women have gone missing and been murdered in Ciudad Juarez. The authorities have failed to effectively prevent or investigate this pattern of crimes.

Marisela Ortíz Rivera is a women's rights defender who works with *Nuestras Hijas de Regreso a Casa*, Our Daughters Return Home, which is one of the organizations created by mothers of the missing and murdered young women of Ciudad Juarez. Her organization has made frequent public criticism of the failure of the authorities to effectively investigate these crimes and campaigns for justice on behalf of the victims and their families.

On 20 March, as Marisela Ortíz Rivera was driving home, she was followed by a van which stopped her vehicle and rammed into her at a set of traffic lights. She managed to escape, but the following day the driver of the van was seen outside her house. Her family reported the details of the van and driver to the police. They have not received any further information regarding action taken by the authorities to investigate the incident or apprehend the driver.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish or your own language:

- expressing concern for the safety of Viviana Rayas who went missing in Chihuahua on 16 March 2003;
- calling on the authorities to investigate urgently, impartially and effectively the fate of Viviana Rayas and inform the family of all steps taken to establish her whereabouts;
- expressing concern for the safety of Marixela Ortíz Rivera and other members of *Nuestras Hijas de Regreso a Casa*, Our Daughters Return Home, and calling for their safety to be guaranteed:

- calling for a prompt, full and impartial investigation into the reported act of intimidation against Marixela Ortíz Rivera and the results to be made public;
- urging prompt, full, effective and impartial investigations, enjoying the full collaboration of state and federal institutions, of all cases of women who have been murdered or gone missing in Chihuahua State in similar circumstances:
- calling for the authorities to take effective steps to prevent, investigate and punish violence against women in Chihuahua State.
