MEXICO"Disappeared": José Pacheco Pineda

Fear for safety: Severo Oyorzábal Mauro Oyorzábal

On 27 June 1997 José Pacheco Pineda was abducted by four unidentified men who allegedly have links with the security forces. Amnesty International has serious concerns for his safety.

José Pacheco Pineda is the leader of the *Organización Campesina Independiente* de *Comundades Indígenas*, (OCICI), Independent Peasant Organization of Indigenous Communities, an indigenous peasant farmers organization in the state of Guerrero.

The names of Severo Oyorzábal and Mauro Oyorzábal, other OCICI leaders, as well as that of José Pacheco Pineda, recently appeared in an article in the weekly magazine *El Proceso*. The article quoted a leaked document from the *Centro de Investigación y Seguridad Nacional*, CISEN, Centre for Investigation and National Security. The document claimed that peasant organizations in the state of Guerrero, such as the OCICI, were linked to the *Ejército Popular Revolucionario*, (EPR), Revolutionary Popular Army, an armed opposition group.

In light of the claims in the media about OCICI leaders Amnesty International fears that the brothers Severo Oyorzábal and Mauro Oyorzábal are at risk of being "disappeared" by the security forces or paramilitary groups, or of being subjected to incommunicado detention and torture in order to extract confessions of association with the EPR.

BACKGROUND INFORMATION

Since the massacre of 17 peasants on 28 June 1995 in Aguas Blancas in an ambush staged by Guerrero state police and government officials (see UA 159/95, AMR 41/15/95, 5 July 1995, and follow-ups AMR 41/16/95, 26 July 1995 and AMR 41/18/95, 17 August 1995), a wave of violence has swept through the state of Guerrero.

The EPR first appeared on 28 June 1996, the anniversary of the Aguas Blancas massacre. Since then the security forces and paramilitary groups have persistently targeted peasants and their leaders for intimidation, arrest, torture, disappearance and extrajudicial execution, accusing them, as well as entire communities and organizations, of belonging to the EPR.

Two recent armed encounters between the EPR and the Mexican army have led to a heightening of tension and an increase in the number of peasant and political activists in Guerrero being targeted for human rights violations such as arbitrary detention and torture (see UA 157/97, AMR 41/35/97, 30 May 1997 and follow-ups AMR 41/37/97, 4 June and AMR 41/38/97, 6 June 1997, AMR 41/43/97, 13 June 1997).

In September 1996, the *Procuraduría General de Guerrero*, (PGE), Attorney General's Office in Guerrero state published a list of journalists it unfoundedly considered to be EPR collaborators. As a consequence Amnesty International believes that a number of journalists listed were targeted for

human rights violations by security forces and paramilitary groups (see UA 227/96, AMR 41/58/96, 27 September 1996).

RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or your own language:

expressing deep alarm at the "disappearance" of José Pacheco Pineda and calling for a prompt and thorough investigation into his abduction and whereabouts;
urging that, if he is being held in detention, he be treated humanely and be granted access to relatives, a lawyer and a doctor;

- expressing concern for the safety of Severo Oyorzábal and Mauro Oyorzábal and calling on the authorities to take steps to guarantee their security; - calling on the authorities to cease making unfounded claims about the involvement of peasant organizations and their members in guerrilla activities, which often results in those named being the target of human rights violations.
