The above East Timorese highlighted with asterisks, arrested after the Santa Cruz massacre and held either in Dili or Jakarta, are to be brought to trial imminently. It is understood that four, including Fernando de Araujo and Joao Freitas da Camara in Jakarta and Francisco Miranda Branco and Gregório da Cunha Saldanha in Dili, have been charged with subversion, which carries a maximum sentence of death. Agapito Cardoso, Domingos Barreto and Virgilio in Jakarta face charges of "expressing public opposition to the government" and all five Timorese in Jakarta were handed over to a district court there yesterday. The trials of Francisco Branco and Gregório da Cunha Saldanha in Dili are scheduled for 12 and 14 March respectively. Charges and trial dates for the remaining six prisoners in Dili have not been announced.

There is concern over possible interference by the authorities over legal arrangements for the defendants. Reports indicate that a team of lawyers sent by the Indonesian Legal Aid (LBH) Foundation, which has been authorized by the defendants to represent them, was denied access to the prisoners last week.

Of the 13 named as facing trial, two in Dili - Jacinto das Neves Raimundo Alves and Saturnino da Costa Belo - are new names that have not appeared either in earlier Urgent Actions or the report <u>Santa Cruz</u>: <u>The Government Response</u> (ASA 21/03/92) issued on 6 February 1992. Fernando de Araujo, facing subversion charges, had reportedly been held incommunicado while recovering from injuries sustained from beatings and torture during interrogation (see UA follow-up ASA 21/02/92, 9 January 1992).

Amnesty International is seeking clarification as to which of the Jakarta detainees listed above were among the 17 Timorese students released on 28 February. There is concern that these students were still being held several days later at the Wisma Jayakarta in Jatinegara, East Jakarta, awaiting a "lecture" from military and government officials. It is not known whether all charges have been dropped against them and there is concern that they may be subject to rearrest in future. It is believed that some will be summoned by the authorities as witnesses in the trials.

Amnesty International is concerned that, as past practice in subversion trials in Indonesia and East Timor has shown, the impending trials may fail to meet international standards of fairness. In particular, Amnesty International is concerned at reports that some of those facing trial have been subject to beatings and torture during interrogation.

Amnesty International believes that most if not all of those to be tried will, if convicted, be prisoners of conscience detained and imprisoned solely for the peaceful expression of protest against Indonesian rule in East Timor.

## FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters

- seeking confirmation that the prisoners named above are to face trial and clarification of the charges against each of them;
- expressing concern at reports that some of those facing trial were reportedly beaten and tortured during interrogation and at the effect this may have on the fairness of the trials;
- seeking clarification on names of students released on 28 February and calling for all persons remaining in custody in connection with the 12 and 19 November demonstrations either to be promptly charged with recognizably criminal offences or unconditionally released; seeking assurance that any trials that are carried out are conducted in a manner that meets international standards for fairness, including, among others, the right to legal counsel to prepare an adequate defense;
- urging the authorities, in the interests of ensuring that trials meet international standards for fairness, to permit independent observers to attend all trials.
