CAMBODIA Kim Sen (Kim San) ] Human rights

The two Cambodian human rights workers named above are to go on trial on 8 July 1999, charged with inciting demonstrators to use violence. Their trial is not expected to last more than two days, and if convicted they could face several years in prison. Amnesty International believes the charges against the men are politically motivated, and would consider them prisoners of conscience if they were convicted.

Kim Sen and Meas Minear work for the Cambodian human rights group LICADHO (Cambodian League for the Promotion and Defence of Human Rights). The charges against them relate to riots in the coastal town of Sihanoukville, where large quantities of toxic waste were imported and dumped by a Taiwanese company in November 1998. When local people became ill and one died, panic spread throughout the area. In December, a protest by local people turned violent and the house of the first deputy governor was attacked. The LICADHO office in Sihanoukville had received many complaints about the toxic waste. Kim Sen and Meas Minear went to monitor the situation on the day of the riots, but were not participating in the demonstration, nor did they organize it.

They were arrested without warrants on 21 December 1998, on the orders of the Deputy Prime Minister and Minister of Interior Sar Kheng. After a month in prison they were released on bail by the Appeal Court on 20 January 1999, for lack of evidence against them. There have been many violations of proper procedures in the course of the case, and Amnesty International's own investigation has found no evidence against them.

### BACKGROUND INFORMATION

A new Cambodian government was formed in November 1998, after elections held in July. The elections were followed by opposition demonstrations, which were violently dispersed in September 1998. During the demonstrations, human rights workers were involved in monitoring the situation in the capital Phnom Penh. They were heavily criticised by Hun Sen, who is now Prime Minister, and accused of leading the demonstrations and supporting the opposition.
