Three more members of the singing troupe *Heemangsae* (Bird of Hope) were arrested under the National Security Law on 15 April. Ho Myong-soon, musical director of *Heemangsae*; Ahn Song-hae, singer and Choi Kyong-ah, employee of Haneum Publishing (musical publishers) were arrested early in the morning at their homes by a group of plain clothes police officers who also confiscated books and music tapes.

Like those arrested earlier, the three prisoners are reportedly accused of planning to stage a musical based on a book which the authorities said praised North Korea and for distributing information about the musical on a computer network. A police officer reportedly told lawyers that the *Heemangsae* members should have curtailed their activities after the arrests of their colleagues.

Amnesty International believes that all eight detained *Heemangsae* members are prisoners of conscience, held in violation of their right to freedom of expression. Their detention appears to be an attempt to prevent them from staging their musical, scheduled to take place this month.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in English or your own language:

- expressing concern at the further arrests of *Heemangsae* members, Ho Myong-soon, Ahn Song-hae and Choi Kyong-ah in violation of their right to freedom of expression.
- urging the authorities to ensure that the three prisoners are protected from ill-treatment in police custody;
- urging the authorities to release all eight detained *Heemangsae* members immediately and unconditionally and to account publicly for the situation of, and charges against, those detained in mass arrests since February 1994.
