LAOSLatsami Khamphoui Feng Sakchittaphong

Bounlu Nammathao (reportedly died June/July 1998)

Thongsouk Saysangkhi (died February 1998)

Amnesty International is dismayed to learn that Latsami Khamphoui and Feng Sakchittaphong are both still suffering from serious health problems for which it appears they have not been provided with adequate medical care. Feng Sakchittaphong is reported to be unable to move without assistance and stays lying down. Latsami Khamphoui is reported to be very weak and pale and has lost a lot of weight.

The two men are detained in extremely harsh conditions at Prison Camp 7 in a remote area of Houa Phanh Province. There are no medical facilities at the camp and they have suffered from a range of illnesses since their detention. Amnesty International fears that unless both men are urgently provided with medical treatment in hospital they will not survive.

Amnesty International has also received unconfirmed information about the death in June or July 1998 of another political prisoner detained at Prison Camp 7. Bounlu Nammathao had already been held for "re-education" without charge or trial for 17 years when he was tried in 1992 and sentenced to life imprisonment for alleged crimes committed prior to 1975. Amnesty International is seeking confirmation of his death and causes.

BACKGROUND INFORMATION

Latsami Khamphoui and Feng Sakchittaphong were detained with their friend Thongsouk Saysangkhi in October 1990. They were adopted as prisoners of conscience by Amnesty International after they were sentenced to 14 years' imprisonment after a grossly unfair trial in 1992 on charges including "making preparations for a rebellion", "propaganda against the Lao People's Democratic Republic" and "libel and slander". All three are former government officials who had advocated peaceful political and economic change in Laos. Appeals that all three should be provided with appropriate medical care for their deteriorating health have been ignored by the authorities; Thongsouk Saysangkhi died in mid-February 1998 reportedly from complications relating to diabetes.

FURTHER RECOMMENDED ACTION: Please send telegrams/express/ airmail letters in English or French or in your own language:

- expressing grave concern that prisoners of conscience Latsami Khamphoui and Feng Sakchittaphong continue to suffer from serious health problems;
- urging that they should be immediately and unconditionally released, pending which they should be provided with the medical treatment they need, including transfer to hospital;
- requesting confirmation of reports of the death of political prisoner Bounlu Nammathao in June or July 1998, and if true, the causes of death.
