## PAKISTANShaukat Ali Kashmiri

On 18 January 1998 Shaukat Ali Kashmiri, Chairman of the United Kashmir People's National Party, was arrested near Bag in Azad Jammu and Kashmir and taken to an unknown destination. Amnesty Internatioal fears that he may be ill-treated in incommunicado detention as torture and ill-treatment are widespread in Pakistan. Shaukat Ali Kashmiri appears to be a prisoner of conscience, detained solely for advocating an independent and united Jammu and Kashmir.

Shaukat Ali Kashmiri was travelling to Bag when two jeeps stopped the car he was in. His driver and two party members witnessed how Shaukat Ali Kashmiri was surrounded by some 10 armed men in plain clothes and forced into one of their vehicles. The three witnesses were beaten when they asked to see an arrest warrant.

The men who carried out the arrests are believed to be members of the security forces, although their specific agency is not known.

## BACKGROUND INFORMATION

Shaukat Ali Kashmiri was previously detained without charge or trial for one month in 1994. He was abducted from near his house in Islamabad in August 1994 and authorities denied any knowledge of his whereabouts. Shaukat Ali Kashmiri was eventually released from an army detention centre in Attock Fort in September 1994. He had not been physically tortured during his detention but been subjected to threats during lengthy interrogation.

## RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- urging the authorities to immediately disclose the whereabouts of Shaukat Ali Kashmiri and to provide him with immediate access to a lawyer and his family;
- urging the authorities to ensure the physical safety of Shaukat Ali Kashmiri;
- urging the authorities to immediately and unconditionally release Shaukat Ali Kashmiri unless he is charged with a recognizable criminal offence;
- calling for an investigation into reports that three witnesses to the arrest were beaten, and for those responsible to be brought to justice.
