### PAKISTANShamu Masih Javed Masih

A new date for the execution of Shamu Masih and Javed Masih has been set for 20 August 1997. The two men were originally due to be executed on 18 July, but were granted a one-month stay of execution by the President of Pakistan.

A member of parliament, acting on behalf of the two men, reportedly appealed for the executions to be suspended on the grounds that relatives of the man Shamu Masih and Javed Masih were convicted of murdering have indicated that they may be ready to forgive the convicted men.

Shamu Masih and Javed Masih were sentenced to death under the Qisas and Diyat Ordinance which defines the offence and punishment of murder in Pakistan in terms of Islamic law. It stipulates that the victim's heirs have the right to pardon the convict or accept compensation.

The introduction of elements of Islamic law into the Pakistan Penal Code has severely limited the possibility of prisoners sentenced to death having their sentences commuted to life imprisonment by the state authorities under Pakistan's Code of Criminal Procedure. However, Article 45 of the Constitution laying down the powers of the President to commute death sentences remains unaffected.

Christian groups in Pakistan continue to call on the President to commute the death sentences against Shamu and Javed Masih. They are also appealing to the President to commute all death sentences to life imprisonment for death row prisoners on the occasion of Pakistan's Golden Jubilee year.
