On 10 January 1992 the nine people named above were detained in a police operation in Ankara. They are currently held at the First Branch (Political Police) of Ankara Police Headquarters. The prosecutor's office at Ankara State Security Court is said to have authorized an extension of their detention period until 25 January. It is feared that the detainees are being interrogated under torture.

Fahri T\_rpan, who served a long prison sentence after the military coup of 1980, was last detained in July 1991 and put on trial in Istanbul State Security Court in connection with the illegal organization Turkish Communist Party/Marxist Leninist (see: UA 241/91, EUR 44/98/91, 16 July 1991).

Co\_kun K\_l\_çkaya was sentenced to 11 years' imprisonment in 1985 in connection with the same political organization.

Bekta\_ Özkan was previously detained in February 1989 and alleged that he was tortured during interrogation (see: UA 44/89, EUR 44/14/89, 9 February 1989 and follow-up EUR 44/19/89, 28 February 1989).

Gazi Köksal was convicted in 1984 in connection with the same political organization.

Ercan Karata\_ was previously detained in July 1987. His brother Erdo\_an is said to have been killed by the security forces in 1991.

## **BACKGROUND INFORMATION**

Turkey ratified the European Convention for the Prevention of Torture on 25 February 1988 and the UN Convention Against Torture on 2 August 1988. However, all information available to Amnesty International indicates that torture is still widespread and systematic in Turkey. Allegations of torture have continued since the transfer of power to a civilian government in 1983. Most allegations

relate to ill-treatment of detainees in police custody during their initial interrogation when they are usually denied access to relatives or a lawyer. In August 1990, the government derogated from Articles 5, 6, 8, 10, 11 and 13 of the European Convention on Human Rights, all of which contain important safeguards for human rights.

Under current legislation the maximum detention period before being formally charged or released is 24 hours; in cases involving three or more suspects or due to the 'nature of the crime' it may be extended to 15 days. This period may be extended to 30 days in areas under emergency legislation or martial law.
