The indictment against Sinan Tanr_kulu, F_rat Anl_, Hanifi ___k, _erif Atmaca, and Servet Ayhan has now been prepared. They will appear at the first hearing of their trial on 1 May, on charges of membership of the armed illegal organisation, the PKK.

Further information on the releases will follow. Meanwhile, please continue appeals for the five boardmembers of Diyarbak_r Human Rights Association who remain in custody.
