Amnesty International is concerned for the safety of the Human Rights Association (HRA) members named above, and about 100 others, who were detained by police in Istanbul on 28 September 1999. According to eyewitness reports police hit people with truncheons and manhandled them, twisting their arms and dragging them along the ground. All may be at risk of torture or ill-treatment in detention.

They had gathered in Istanbul's Sultan Ahmet Square for a press release about disturbances at Ankara Central Closed Prison two days earlier which lead to the deaths of at least 11 prisoners. Police reacted by sealing off the square for about three hours and detaining all those who arrived at the square.

Five lawyers, including Eren Keskin, President of the Istanbul branch of the HRA, were among those detained but later released.

It is understood that the detainees are being held in police custody at the Law and Order Branch of Police Headquarters in Istanbul.

BACKGROUND INFORMATION

On 26 September 1999 11 prisoners lost their lives in a violent clash between prisoners and guards and soldiers in Ankara Central Closed Prison. In reaction to this incident, prisoners at prisons throughout Turkey took warders hostage and an extremely tense situation continues in these prisons.

The Human Rights Association is an independent organization founded in 1986 by a group of lawyers, publishers, artists and human rights activists to monitor abuses and protect human rights.

Since its foundation the HRA has been outspoken in its condemnation of human rights violations by government agencies and armed opposition groups. Its headquarters are in Ankara, but it has branches throughout Turkey.

From the start the HRA's courageous defence of human rights has led to considerable pressure from the authorities with its members imprisoned, tortured and sometimes even killed.

In 1998 the former President of the HRA, Ak_n Birdal, narrowly escaped an assassination attempt, only to be imprisoned by the authorities in May 1999 for the peaceful expression of his non-violent opinions. Amnesty International adopted him as a prisoner of conscience and campaigned for his unconditional release. He was eventually released on 25 September on medical grounds. His sentence was suspended for six months.

- expressing concern for the safety of Leman Yurtsever, Musa K_l_ç, _en Süer Kaya, K_vanç Sert, Nimet Tanr_kulu, Zaide Honca, Ümit Efe, Zehra Y_lmaz and approximately 100 others detained by police on 28 September 1999 in Istanbul's Sultan Ahmet Square;
- asking for assurances that they will not be ill-treated in any way in detention;
- expressing concern at reports that police hit individuals with truncheons and manhandled them during the operation;
- asking to be informed about any charges brought against them.
