Mehmet Ihsan Arslan has presented himself at Ankara Police Headquarters, following the issue of a warrant for his arrest. According to reports, he and Ak_n Birdal have been interrogated at the Anti-Terror Branch of Ankara Police Headquarters and it is expected that they may soon be brought before a judge. Amnesty International considers both to be prisoners of conscience.

It has also been reported that the prosecutor's office intended to write to the Turkish Grand National Assembly to demand that parliamentary immunity for Fetullah Erba_ be lifted so that he, too, could be detained and possibly charged. If this happened, he would also be considered to be a prisoner of conscience.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or in your own language:

- expressing concern about the detention of Ak_n Birdal and Mehmet Ihsan Arslan;
- pointing out that they are considered to be prisoners of conscience as they have in no way advocated or committed violence;
- calling for their immediate and unconditional release;
- seeking assurances that they are being treated humanely in detention in accordance with internationally recognized standards;
- noting that Fehtullah Erba would also be a prisoner of conscience if detained.
