UA 21/04 "Disappearance"/ Fear of torture and ill-treatment 14 January 2004

RUSSIAN FEDERATION Khamzat Osmaev (m), aged 50

Khamzat Osmaev has "disappeared" after he was detained on 12 January 2004 in the republic of Ingushetia, apparently by members of the Russian federal forces. Amnesty International fears that he may be tortured or ill-treated.

According to the Russian human rights organization *Memorial*, at about 5pm a white vehicle with tinted windows and no number plates stopped outside the medical massage centre Khamzat Osmaev runs in the village of Plievo, on the outskirts of the Ingush capital, Nazran. Seven masked men in military uniforms got out, seized Khamzat Osmaev (who was outside the building, trying to start his own car), forced him into their vehicle and drove off in the direction of Nazran.

Witnesses say the men spoke Russian with no accent, and Amnesty International believes they may have been members of the Russian federal forces.

Khamzat Osmaev fled from the Chechen capital Grozny to Ingushetia in 1999, where he works as a physiotherapist. In Chechnya he had been a relatively well-known athlete, and it is alleged that the Russian Federal Security Service (FSB) has a picture of him from the early 1990s, where he can be seen at a ceremony standing next to a man now known to be a Chechen field commander. About a year ago, Khamzat Osmaev was warned not to go to Chechnya, as there might be an FSB warrant for his arrest.

# **BACKGROUND INFORMATION**

Over the last few years, Amnesty International has received regular reports about arbitrary arrests and "disappearances" during the armed conflict in the Chechen Republic. People who "disappear" are often tortured and ill-treated. During the last year there have been more and more reports that military raids, during which serious human rights violations have been committed, have started to spread across the border from Chechnya to Ingushetia, where refugee camps, Chechen settlements as well as Ingush villages have been targeted.

# RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Russian or your own language:

- expressing concern for the safety of Khamzat Osmaev;
- calling on the authorities to establish whether Khamzat Osmaev has been detained by federal forces and, if so, urging them to either release him immediately or charge him with a recognisably criminal offence in a court of law, in line with Russia's obligations under international human rights law;
- calling on the authorities to establish the whereabouts of Khamzat Osmaev and inform his relatives;
- if it is established that federal forces were responsible, urging the authorities to immediately initiate a criminal investigation into the "disappearance" of Khamzat Osmaev and to bring those responsible to justice in a court of law.
