## POLICE THREATEN MAN COMPLAINING OF TORTURE

**A man who was abducted and tortured by police in the Russian republic of Kabardino-Balkaria has been threatened by police officers as the investigation into his allegations is making progress.**

**Inal Berov** was abducted on 6 March 2012 from the car repair garage where he worked at the time, by a group of armed men, taken to a Ministry of the Interior building in Nalchik, the capital of Kabardino-Balkaria, held there overnight, and according to him tortured, which included repeated severe beatings and electric shocks. Inal Berov was left with injuries including a fractured spine and concussion. He filed an official complaint and a criminal investigation into his allegations was opened on 4 April 2012. Since then, police have intimidated and harassed Inal Berov and his family. In particular, a criminal case was fabricated against him, but he was cleared of all charges by the investigating authorities on 28 February 2013.

No one has yet been brought to justice for abducting or torturing Inal Berov. He and his lawyer have been pressing for an effective investigation. In June 2013, the investigating authorities brought Inal Berov and police officers from the unit allegedly involved in his abduction and torture to meet face to face and put their claims to each other. During these meetings, at least two of those police officers made veiled threats towards Inal Berov. One said that he was beginning to develop a personal dislike of Berov, and added, after the meeting, that he was aware of Berov's criminal activities. Another, a senior officer from the criminal investigation unit, promised during the meeting that he would soon produce evidence that Inal Berov had been involved in armed robbery. Berov regards these warnings as a promise to fabricate a new criminal case against him, and has complained about them to the Prosecutor's Office.

### **Please write immediately in Russian, English or your own language:**

- Urging the authorities to order a prompt, impartial and effective investigation of Inal Berov's allegation that he has been threatened by police officers, and bring those responsible to justice;
- Calling on them to suspend those police officers from duty until this investigation and the investigation into Inal Berov's allegation that he was abducted and tortured by police officers on 6 March 2012 are completed;
- Calling on them to do everything necessary to ensure the safety of Inal Berov and his family.

## POLICE THREATEN MAN COMPLAINING OF TORTURE

### ADDITIONAL INFORMATION

The use of torture and other cruel, inhuman or degrading treatment by police and other law enforcement officials is regularly reported across the Russian Federation. Allegations of torture are particularly frequent in the North Caucasus, which includes Kabardino-Balkaria. These are often accompanied by allegations of enforced disappearance, unlawful detention, denial of access to a lawyer of one's choice and other human rights violations. People who complain about violation of their human rights by law enforcement officers and demand investigation and prosecution of the perpetrators often face further intimidation and harassment.
