UA 92/98 Peaceful demonstrators reportedly beaten, at least 20 detained 23 March 1998

Between 20 and 50 people were arrested and beaten by police following a peaceful demonstration in the Belorussian capital Minsk on 22 March 1998. Amnesty International is urging the authorities to initiate prompt and impartial investigations into all allegations of ill-treatment of demonstrators by the police and to bring anyone found responsible to justice.

The demonstration was held to mark the 80th anniversary of the declaration of an independent state of Belorussia (as it was formerly known).Those detained included journalists and members of the opposition party, the Belarussian Nationalist Front. Women and minors, including a 15 year old boy, Pavel Rakhmanov, were also arrested.

Despite statements from Belarussian officials that the arrests were made in response to protestors throwing smoke bombs, unofficial sources maintain that the 10,000-strong demonstration was entirely peaceful.

Seven people have now been released, having been found guilty of shouting censored slogans and insulting the President, Alyaksandr Lukashenka. One man found guilty was fined 5 million Belarussian roubles (about \$100 USD), and two women were given warnings.

Five local members of the Helsinki Committee human rights group who attended the demonstration were also detained. They were released an hour later.

#### PUBLIC

An unknown number of people are awaiting trial in detention centres. No further information is known at this stage.

## BACKGROUND INFORMATION

Amnesty International is concerned at the apparent pattern of ill-treatment and imprisonment of members of the opposition as a result of peaceful strikes and demonstrations in Belarus, and has repeatedly raised this with the Belorussian authorities.

The continuing arrests of journalists is also a matter of grave concern. In 1997, seven employees of the Russian television station ORT were detained and reportedly charged with violating Article 80 of the Belarussian Criminal code, under which illegal border-crossing is punishable by imprisonment of up to five years. Amnesty International considered the journalists to be prisoners of conscience, detained for their professional non-violent activities as media workers.

# RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English, Russian or your own language:

-calling for the immediate release of any demonstrators held in police custody solely for exercising their right to freedom of assembly;

-seeking assurances that no-one in the future will be subjected to ill-treatment or imprisonment by the police solely on the grounds of their political beliefs and for peacefully expressing their right to freedom of assembly;

-urging the authorities to initiate prompt and impartial investigations into all allegations of ill-treatment of demonstrators by the police, and to bring anyone found responsible to justice;

-urging the authorities to provide compensation to the victims of police abuse and to inform all law enforcement officials that torture and ill-treatment are prohibited in any circumstances under the provisions of the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment, and the International Covenant on Civil and Political Rights (ICCPR), to which Belarus is a party as a successor state of the USSR.
