BELARUSYury Zakharenko

The former Minister of the Interior, Yury Zakharenko, has now been missing for more than six and a half months. He "disappeared" at the start of the unofficial presidential elections in May 1999. Amnesty International fears he may have been deliberately targeted by the authorities to silence a prominent and outspoken member of Belarus's peaceful opposition.

Since he "disappeared" there has been very little new information about his fate. His wife, Olga Zakharenko, has reportedly been repeatedly threatened and intimidated. At the start of October 1999 she reportedly stated in a radio interview that she has been constantly subjected to anonymous threatening telephone calls and also has been warned to leave the country.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in your own language:

urging that the whereabouts of Yury Zakharenko be immediately established and made known to his family, and that if he is in police custody he be given immediate access to his family, and to legal representation;
urging that any criminal charges against him are made public;
urging that he is protected from any form of ill-treatment;
urging that his wife, Olga Zakharenko, and two daughters be protected from

any intimidation.

If a voice answers, repeat "fax" until connected.
