Amnesty International has been informed that Sayyed Ahmad al-Tokhi was released from detention on 6 October 1997. However, Kamal Khalil Khalil, Akram Alfy Mikha'il and Mostafa Mohammad Mostafa, remain in detention.

Amnesty International considers the three men to be prisoners of conscience detained for their peaceful activities in opposition to a new agricultural law.

Sayyed Ahmad al-Tokhi, a lawyer working for the Egyptian Organization for Human Rights, was detained for nearly two months, reportedly on charges which included inciting farmers to oppose the new agricultural law, Law 96 of 1992, and hindering its implementation.

Further arrests are reported to have taken place since the implementation of the law began on 1 October. In the last few days security forces arrested 10 tenant farmers in Giza Governorate. They were later released but were then forcibly evicted from the land they rented. This law raises agricultural rents and permits landowners to evict farmers, abolishing the provisions of the 1952 agrarian reform law which guaranteed security to farmers on rented land.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic, French or in your own language:

- welcoming the release of Sayyed Ahmad al-Tokhi, but expressing concern that he was detained as a prisoner of conscience for nearly two months;
 continuing to call for the immediate and unconditional release of Kamal Khalil Khalil, Akram Alfy Mikha'il and Mostafa Mohammad Mostafa as prisoners of conscience;
- seeking information on the legal status of the three men and the current whereabouts of Akram Alfy Mikha'il and Mostafa Mohammad Mostafa and urging that they be protected from any form of torture or ill-treatment;
- urging the authorities to release all those detained solely for exercising their right to campaign peacefully against Law 96 of 1992 and to ensure that no others are arrested on the same grounds.
