IRAN Mohammad Khandjari, taxi driver, aged 33

Amnesty International fears that Mohammad Khandjari may be subjected to torture. He was reportedly arrested at dawn on 12 November 1994 and is believed to be held in Rasht Prison.

Mohammad Khandjari was arrested at his home in South Tehran, and reportedly beaten up in front of his wife by members of the Pasdaran (Revolutionary Guards) before being transferred to Rasht Prison. He was apparently arrested for his alleged participation in the riots that took place in Qazvin on 3 August 1994. The riots were sparked off by a government proposal to create a new province with Qazvin as its capital, which was narrowly defeated by the Majlis (Consultative Assembly). The demonstrators wanted Qazvin, a leading industrial city, to become the centre of a new province independent from neighbouring Zanjan. There were a number of arrests and at least 13 people were reportedly shot dead and 80 wounded.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- urging that Mohammad Khandjari be given immediate access to a lawyer of his own choosing, to family members, and to independent medical care if required;
- seeking information about the precise charges that have been brought against him and any information regarding his trial;
- urging that he be humanely treated.
