IRAN Ali Akbar Saidi-Sirjani, writer

On 27 November 1994, the Islamic Republic News Agency (IRNA) reported that Ali Akbar Saidi-Sirjani had died of a heart attack in an unspecified Tehran hospital on the same day. Amnesty International is gravely concerned by his death and is calling for a full investigation into the circumstances surrounding it

Ali Akbar Saidi-Sirjani was arrested on 14 March and was believed to have been held in incommunicado detention until recently when he was reported to have been put under house arrest in a house owned by the government where he remained incommunicado.

Officials have accused him in the press of drug abuse, brewing alcohol, homosexual acts, links with espionage networks and receiving money from "counter-revolutionary" circles in the West. Some of these offences carry the death penalty. However, the real reason for his arrest appeared to be open letters he had written to the government objecting to the censorship of dissenting voices in Iran.

Ali Akbar Saidi-Sirjani's family have said that they have no knowledge of him having any prior history of heart trouble.

Most of Ali Akbar Saidi-Sirjani's writings were effectively banned in Iran, as he was unable to get a permit to have them printed and distributed.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- expressing grave concern at the death of Ali Akbar Saidi-Sirjani;
- urging an immediate thorough and independent investigation into the circumstances surrounding his death;
- urging that the conclusions and methods of the investigation be made public.
