On 20 March 1996, Matter al-Shubeki, Salah al-Shubeki and Wa'el al-Shubeki, cousins in their 20s, were sentenced to death by hanging by a three-judge Criminal Court in Gaza. They were convicted of killing a 50-year-old Palestinian moneychanger, 'Abdallah Shedada, and stealing from him in Gaza City on 29 February 1996. The three pleaded guilty to the murder charge. They have 10 days to file an appeal.

Ma'mun 'Attalla, the fourth defendant, pleaded not guilty to the murder charge. He was convicted of being an accessory and was sentenced to life imprisonment with hard labour. However, Khaled al-Qidrah, Attorney-General in the Palestinian Authority, said that prosecutors would appeal against the sentence and would ask a higher court to sentence Ma'mun 'Attalla to death as well.

BACKGROUND INFORMATION

Five death sentences have been imposed over the last 10 days in the Palestinian Authority. However, Amnesty International welcomes the news that the death sentences passed on 'Attiya Abu Nuqayreh and Ala' 'Akel (see EXTRA 39/96, MDE 15/19/96, 13 March 1996) were commuted on 21 March 1996. The case of Tha'er Fares, a policeman sentenced to death by a Military Court having been convicted of murder (see EXTRA 50/95, MDE 15/14/95, 5 May 1995), still remains. Yasser Arafat has not ratified his death sentence, and he remains held in prison.

Amnesty International fully recognizes the right and responsibility of authorities to bring to justice those who have committed crimes. However, the organization opposes the death penalty without reservation as a violation of the right to life and the ultimate form of cruel, inhuman and degrading punishment.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic or your own language:

- stating that you in no way condone crimes of violence but that you oppose the death penalty in all cases as a violation of the right to life;
- urging that the death sentences passed on Matter al-Shubeki, Salah al-Shubeki and Wa'el al-Shubeki be commuted;
- urging that Ma'mun 'Attalla should not be sentenced to death;
- welcoming the commuting of the death sentences passed on 'Attiya Abu Nuqayreh and Ala' 'Akel and urging the Palestinian Authority, in line with world trends against the use of the death penalty, to abolish the death penalty and to ensure that any new penal code excludes the death penalty as a punishment for both civilians and military.
