## PALESTINIAN AUTHORITYKhalil al-Sakni, aged 24 Hatem Abu Wadi, aged 21

On 15 December 1996 Khalil al-Sakni and Hatem Abu Wadi were sentenced to death by firing squad by a Military Court in the Palestinian Authority. They are reportedly members of the *Hamas* military wing, *Izzadin al-Qassem*, and were convicted of killing a policeman and seizing his gun, and of participating in the killing of a civilian.

They have the right to appeal within 15 days against the death sentences.

Another defendant, 18-year-old 'Abdullah al-Latif al-Ashkur, had his death sentence reduced to 20 years' imprisonment on account of his age.

#### BACKGROUND INFORMATION

There have been 12 death sentences (including the above) imposed since the establishment of the Palestinian Authority in May 1994. Two death sentences have been commuted. None have been carried out.

Amnesty International recognizes the right and responsibility of authorities to bring to justice those who have committed crimes. However, the organization opposes the death penalty without reservation as a violation of the right to life and the ultimate form of cruel, inhuman and degrading treatment or punishment.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English, Arabic or your own language:

- stating that Amnesty International does not condone crimes of violence, but opposes the death penalty in all cases as a violation of the right to life; urging that the death sentences passed on Khalil al-Sakni and Hatem Abu Wadi be commuted;
- urging the Palestinian Authority, following world trends against the death penalty, to abolish the death penalty and ensure that any new penal code excludes the death penalty as a punishment for both civilians and military.
