Death penalty

'Ibayd al-Shish

On 22 April 1996 Jamil al-Shish and 'Ibayd al-Shish were sentenced to death by the Higher Criminal Court in Amman. The death sentences will be reviewed before the Court of Cassation and, if upheld, must be ratified by King Hussein Bin Talal before they can be carried out.

Jamil al-Shish and 'Ibayd al-Shish were found guilty of the premeditated murder of their sister, Amna.

Amnesty International does not condone crimes of violence, and recognizes the responsibility of governments to bring the perpetrators to justice. However, it opposes the death penalty in all cases as a violation of the right to life and of the right not to be subjected to cruel, inhuman or degrading punishment as specified in the Universal Declaration of Human Rights. Amnesty International has repeatedly expressed its concerns to the Jordanian authorities about the increase in the use of the death penalty over the last two years.

BACKGROUND INFORMATION

At least eight people have been sentenced to death in Jordan in 1996. Two death penalties are known to have been carried out this year: on 12 March 1996, Da'ud Khalaf al-Asmara and 'Abd al-Karim al-Daja were executed. In 1995 at least 12 people were executed, including, Hani 'Abd al-Rahim, Yusef Mashale, Amin Huwimed, Nimer Rawahaneh and Ra'ed Ausheibat.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in English or your own language:

- urging that the death sentences imposed on Jamil al-Shish and 'Ibayd al-Shish be commuted in the event that they are upheld by the Court of Cassation;
- stating unconditional opposition to the death penalty and urging that no future executions be carried out;
- urging the Jordanian Government to sign the Second Optional Protocol to the International Covenant on Civil and Political Rights aimed at abolishing the death penalty.
