The President signed final execution decrees for Ahmad 'Ali Mansour, Badea' Waleed Hamada and Remi Antoan Zaatar on 14 January. They are to be executed before dawn on Saturday, 17 January.

Ahmad 'Ali Mansour is to be hanged, while Badea' Waleed Hamada and Remi Antoan Za'atar are to be executed by firing squad. They are to be executed at Roumieh prison, in the capital, Beirut.

The execution decrees have also been approved by the Prime Minister and the Minister of Justice.

There is no new information about Fadi Ahmad Mereish.

BACKGROUND INFORMATION

All three men were convicted of murder. There have been no executions since President Lahoud took office on 24 November 1998.

Amnesty International opposes the death penalty in all circumstances, regardless of the crime for which it is imposed, as a violation of the right to life and the right not to be subjected to cruel, inhuman or degrading treatment or punishment. The finality and cruelty inherent in the death penalty render it incompatible with norms of modern-day civilized behaviour and an inappropriate and unacceptable response to crime.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Arabic, French or your own language:

- urging the Lebanese authorities to halt these executions immediately;
- expressing sympathy for the families and friends of the alleged victims of the men named above;
- expressing concern at the apparent reintroduction of the death penalty in Lebanon after five welcome years of a de facto moratorium on its application;
- urging the authorities to carry out no more executions in Lebanon
- urging the Lebanese government to take effective steps towards abolishing the death penalty.
