The three relatives of Mamun al-Humsi named above were arrested on 26 December, after they applauded him at the latest hearing of his trial, at the Damascus Criminal Court. They are now held in 'Adra Prison, where Mamun al-Humsi is held, apparently without access to lawyers or their family, and may be at risk of torture or ill-treatment. Amnesty International considers all three to be prisoners of conscience, detained solely for the peaceful expression of their opinions.

Member of parliament Mamun al-Humsi was arrested on 9 August. He was put on trial before the Criminal Court in Damascus on 30 October, charged with offences including "attempting to change the constitution by illegal means".

On 26 December Mamun al-Humsi's lawyers reportedly reaffirmed request for 20 defence witnesses to be called to testify, including other MPs, political analysts and writers, as well as the former minister of interior, Muhammad Harba. The judge rejected the request on the grounds that the testimony would be "unnecessary and counter-productive". Mamun al-Humsi reportedly shouted angrily and defied the judge's order to keep silent. His nephews Riad Sairafi and Ahmad Sairafi, and his brother-in-law Jamal al- Masri, applauded, and continued shouting in al-Humsi's support after they had left the court building. They were arrested in the street by members of the military intelligence, accused of provoking "public disorder". Until now they have not been brought officially before a judge for interrogation.

Other relatives of Mamun al-Humsi are also reportedly being harassed and intimidated by the Syrian authorities.

BACKGROUND INFORMATION

Mamun al-Humsi is one of several prominent opposition figures now on trial before the Criminal and State Security Courts. Among them is another independent member of parliament, Riad Seif (see UA 226/01, MDE 24/029/01, 7 September 2001, and follow-ups).

FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Arabic, English, French or your own language:

- calling for Riad Sairafi, Ahmad Sairafi and Jamal al-Masri to be released immediately and unconditionally, as Amnesty International considers them prisoners of conscience, detained solely for the peaceful expression of their political opinions;
- seeking assurances that they are being well treated in custody and not tortured or ill-treated;
- urging the authorities to ensure that they are allowed immediate access to their families, lawyers and any medical care they may need;

- expressing concern at reports that other relatives of al-Humsi are being harassed by the authorities.
