TUNISIA Moncef MARZOUKI, human rights activist Abderrahman HANI, human rights lawyer Ahmed KAHLAOUI, professor and trade unionist

Abderrahmane Hani was released on bail on 23 April 1994. Following on from his announcement that he would stand as a candidate for the Presidential Elections held in March 1994, he was arrested on 15 February on charges of setting up an illegal association and spreading false information. Although welcoming his release, Amnesty International is concerned that he still awaits trial for having peacefully exercised his right to freedom of expression.

Moncef Marzouki continues to be detained on charges of spreading false information liable to disturb public order and insulting the judiciary authorities. The accusations are based on a declaration to a foreign media he denies making. Arrested on 24 March 1994, he also had announced early in the year his candidature for the Presidential Elections. He is a prisoner of conscience and should be immediately and unconditionally released.

The trial of Ahmed Kahlaoui, arrested on 4 March 1994 began on 2 May 1994. He was initially charged with distributing unauthorized leaflets condemning the embargo against Iraq and the Hebron massacre, but further charges were later added, including that of inciting racial hatred. New evidence that has come to light after his defence lawyers were recently allowed to see the leaflets in question, indicates that one of the leaflets contains a phrase advocating violence. It is not clear if Ahmed Kahlaoui is the author or co-author of this leaflet, or whether he intended to distribute the leaflet knowing its content. In view of this new information, and pending further clarifications, his status as a prisoner of conscience cannot be determined. However, Amnesty International continues to be concerned that he may not be receiving a fair trial and will continue to monitor his case.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in French, Arabic, English or in your own language:

- urging the Tunisian authorities to immediately and unconditionally release Moncef MARZOUKI, who is being detained as a prisoner of conscience for peacefully exercising his right to freedom of expression;

- urging that Ahmed KAHLAOUI be given a prompt and fair trial in accordance with internationally accepted standards;

- welcoming Abderrahmane HANI's release on bail, but expressing regret that he was imprisoned as a prisoner of conscience and urging that the charges brought against him for having peacefully exercised his right to freedom of expression be dropped.
