TUNISIA: Hamma HAMMAMI, member of the unauthorized Parti communiste des ouvriers tunisiens (PCOT), Tunisian Workers' Communist Party

Hamma Hammami, a prisoner of conscience, has been denied access to his family and lawyers since 7 December 1994 when he embarked on a hunger-strike. Amnesty International is concerned for his health and that his present whereabouts are unknown.

After Hamma Hammami went on hunger-strike on 7 December, his family and lawyers were denied access to him and told that he was being "punished". Prisoners on hunger-strike are held permanently chained in solitary confinement with inadequate clothing and bedding. His family and lawyers were informed that he had been transferred to another prison but they have been unable to establish his present whereabouts after receiving conflicting reports from the prison authorities about his place of detention. They have also been unable to obtain any further information from other authorities including the Ministry of the Interior. In addition, Hamma Hammami suffers from heart and kidney conditions and Amnesty International fears that he may currently be denied the medical care that he needs for these.

Since being sentenced earlier this year to a total of 8 years and 7 months' imprisonment, Hamma Hammami has gone on three hunger-strikes to protest at his conditions of detention, at lack of access to medical care and at restrictions on family visits.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters in French, Arabic, English or in your own language:

- expressing concern that Hamma Hammami is being denied access to his lawyers, stating that this is in breach of Tunisian law, which guarantees detainees' right to access to legal counsel at all times, and is inconsistent with international standards on the subject of access to legal counsel;
- urging the authorities to ensure that he have prompt and full access to medical care;
- emphasising again (as in earlier appeals this year) that Hamma Hammami has been imprisoned solely for peacefully exercising his internationally recognized right to freedom of expression and association and insisting that he be immediately and unconditionally released.
