US OPERATION IN HAITI SHOULD BE ACCOUNTABLE FOR HUMAN RIGHTS VIOLATIONS

WASHINGTON -- Amnesty International said the current situation in Haiti -- where public order is brutally enforced by the Haitian military authorities while the US authorities stand idly by -- is dangerously wrong.

Reports today indicate that Haitian police killed at least one and possibly other Haitian civilians since the United States forces arrived in Haiti. The man, allegedly beaten to death, reportedly died yesterday when uniformed Haitian police brutally assaulted crowds outside Port-au-Prince harbour.

"If killings by the Haitian military authorities happen in front of US troops -- and the US is silent -- then the US appears to condone human rights violations and becomes a partner with those who commit such abuses," Amnesty International said. "The US authorities should make it clear to their Haitian counterparts that human rights violations cannot be tolerated and that there are existing international law enforcement standards which they are obliged to uphold at all times. These guidelines should be disseminated among the Haitian population."

The United Nations and the United States must not abandon responsibility for protecting people who continue to be assaulted and killed by the Haitian military and their accomplices. Amnesty International said. An immediate deployment of an international observation team could reduce the risk of human rights violations by acting as a dissuasive presence and help the Haitian people to know their rights.

All UN-mandated forces in Haiti operation, including US military personnel, should be instructed that they have a duty to report human rights violations. US military personnel in Haiti should not be "silent witnesses" to human rights violations.

The organization also calls for an in-depth investigation into the yesterday's clashes and other incidents of apparent excessive use of police force. The investigation should include an independent forensic enquiry to determine the cause of death of fatalities. It should also determine who was responsible for the fatalities. ENDS\
