The 1965 prisoners - update

On 31 July 1995, Amnesty International issued a document entitled *The 1965 Prisoners: A Briefing* (ASA 21/36/95). Appended to that document was a list of prisoners still believed to be held in connection with the alleged coup attempt by the Indonesian Communist Party (PKI) in October 1965. This alleged coup preceded the coming to power of the present New Order Government of President Suharto.

Amnesty International has since received confirmation that several of those in the original list were previously released. This updated list is enclosed for your information.
