Mexico: Julio MACOSSAY VALLADO, lawyer

Amnesty International is concerned at reports that on 8 August 1990, Julio Macossay, a human rights lawyer and legal adviser to workers in poultry farms in Mérida, in the state of Yucatán, was attacked and threatened with death. Reports indicate that two individuals approached him from behind in the street and threatened to kill him if he did not leave Yucatán. He was then hit in the abdomen with a piece of lead piping.

Julio Macossay spent nearly three months in prison earlier this year. He had been providing legal advice to workers at local farms in their efforts to improve working conditions and set up an independent trade union. Accused of various offences, including attacks on transportation and issuing threats, which he vigorously denied, he spent 50 days on hunger strike. While in detention, he reportedly received threats, warning him to abandon his activities. He was eventually released on 30 May for lack of evidence.

In the light of recent human rights violations against human rights advocates, including the apparent extrajudicial killing of lawyer Norma Corona Sapién in May 1990, and the death threats issued against Jorge Casteñeda Gutmán and Víctor Clark Alfaro, the following month, Amnesty International believes that a thorough investigation into the attack and threats on Julio Macossay should be conducted immediately and those responsible brought to justice.

## RECOMMENDED ACTION: Telegrams/express and airmail letters:

- expressing concern at the reported attack and death threats against Julio Macossay on 8 August 1990;
- urging that an investigation into these allegations be conducted immediately and that those responsible be brought to justice.
