



## China: Lawyers and Activists detained or questioned by police since 9 July 2015

Amnesty International has collated the list based on various sources and attempted to confirm all information. However, verification remains difficult and not all the information may be up to date.

Note: In China, "summoned" refers to a particular procedure detailed in Criminal Law article 92 by which an individual regarded as a "criminal suspect" can be interrogated at a designated place but need not be arrested or formally detained.
