

SUMMARY

Immediate action is needed to stop the imminent destruction of a mass grave site in the southern Iranian city of Ahvaz, Khuzestan Province, where the bodies of dozens of the several thousand political prisoners who were extrajudicially executed by the authorities in August and September 1988 are buried. This year marks the 29th anniversry of the mass prisoner killings.

Construction around the site was brought to Amnesty International's attention in May 2017, at which time the organization issued a <u>press release</u> calling on the Iranian authorities to stop destroying the mass grave site. The organization has since obtained new footage which shows the site is gradually being buried beneath massive piles of construction waste and is, therefore, under increased threat.

OBJECTIVE

• To stop the destruction of the mass grave site in Ahvaz containing the bodies of dozens of victims of the 1988 mass prison killings and ensure that it is preserved and protected until proper, independent investigations can be carried out.

CALLS ON THE IRANIAN AUTHORITIES

- Immediately stop the destruction of the mass grave site in Ahvaz containing the bodies of dozens of victims of the 1988 mass prison killings and ensure that it is preserved and protected until proper, independent investigations can be carried out.
- Stop the harassment and persecution of human rights defenders seeking truth, justice and reparation for past violations, notably the relatives of the victims of mass executions in 1988.
- Conduct a thorough, effective and independent investigation into the extrajudicial executions of 1988, and bring to justice those responsible in fair proceedings without recourse to the death penalty.
- Recognize, in words and practice, that mass graves are crime scenes that require professional
 forensic expertise to undertake exhumations and ensure preservation of evidence and accurate
 identification of bodies.

BACKGROUND

The mass grave site in Ahvaz contains the remains of at least 44 people who were among several thousand political prisoners extrajudicially executed across the country in 1988. There are other similar mass graves in Iran, but this action focuses solely on the one in Ahvaz, where there is an imminent risk of the mass grave being destroyed by the city council.

The mass grave site is located on a barren piece of land 3km east of Ahvaz's Behesht Abad cemetery. The prisoners buried there were rounded up and forcibly disappeared before being killed in secret. Their bodies were then dumped at night into freshly dug trenches. The authorities poured concrete over the mass graves immediately after the burial, apparently to prevent family members from digging up the ground and recovering the bodies of their loved ones.

Photographic and video evidence obtained by Amnesty International and the human rights organization <u>Justice for Iran</u> show bulldozers working on a construction project directly alongside the mass grave site in Ahvaz, as well as piles of dirt and construction debris surrounding the grave. The evidence features in a video created by the two organizations.

The Iranian authorities have made no official announcements about their plans. However, in May 2017, a construction worker told one family member that the work under way to widen the road running alongside the mass grave site would bring the road very close to the site and that the next phase of works would raze the concrete structure completely to clear the area for a "green space" or a commercial development.

Over the past three decades, the Iranian authorities have denied the families of the victims of the 1988 executions the right to give their loved ones a dignified burial and forbidden them from holding commemorative gatherings or decorating the mass grave sites with memorial messages. They have regularly tormented the families by referring to the mass grave sites of the victims of the 1988 executions as "damned land" (*la'nat abad*). In Ahvaz, families have long been forced to walk through piles of rubbish to visit the resting place of their dead loved ones.

To date, no Iranian officials have been investigated or brought to justice for the 1988 extrajudicial executions. Some of the alleged perpetrators continue to hold political office or other influential positions, including in the judiciary.

APPENDIX 1: SAMPLE LETTER

Dear members of Ahvaz City Council

I am distressed to learn of the ongoing desecration and destruction of a mass grave site in Ahvaz which contains the bodies of dozens of people killed during the mass extrajudicial executions of several thousand political prisoners across Iran in August and September 1988.

I urge you to immediately stop the destruction of the mass grave site and ensure that it is preserved and protected until proper, independent investigations are carried out and those responsible are brought to justice in fair proceedings without recourse to the death penalty.

I respectfully remind you that mass graves are crime scenes that require professional forensic expertise to undertake exhumations and ensure preservation of evidence and accurate identification of bodies. Families of victims also have the right to truth, justice and reparation, including the right to bury their loved ones in dignity.

APPENDIX 2: SAMPLE PETITION

Urgent action is needed to stop the destruction of a mass grave site in the city of Ahvaz, southern Iran, which contains the bodies of dozens of people killed during a wave of extrajudicial executions across the country in August and September 1988.

During that time, several thousand political prisoners were killed in secret and their bodies were dumped in ditches at night. The authorities have never permitted the victims' families to give their loved ones a dignified burial or hold memorials. In Ahvaz, the authorities poured concrete over the mass graves and the site was subsequently turned into a rubbish dump.

Nearly three decades on since the killings, the authorities are undertaking a construction project that appears aimed at destroying the victims' final resting place. This would erase crucial evidence of past crimes and deprive the families of their rights to truth, justice and reparation, including the right to bury their loved ones in dignity.

Mass graves are crime scenes that must be preserved and protected until proper, independent investigations are carried out and those responsible are brought to justice, in fair proceedings without recourse to the death penalty.
