The nine people named above are still detained in police or gendarmerie custody following their arrest in early January. They are yet to be charged and are now held in contravention of Burundian law, which says that detainees can be held for questioning (*Garde à vue*) for a maximum of 14 days.

With the exception of Nathanael Bisesere, they are accused having been involved in an attack on a civilian aircraft coming in to land at Bujumbura airport in December 2000. The government has blamed the attack on an armed opposition group, the Forces nationales de libération (FNL), National Liberation Forces, which is very active in the area. The FNL has denied responsibility. The State Public Prosecutor set up a special commission to investigate the attack, but this has been beset by problems and has yet to produce a report. In late January, the Commander of the District de Bujumbura, a gendarmerie detention centre, was suspended from the commission after he refused to allow the State Public Prosecutor and the UN Special Rapporteur on Burundi access those suspects who are being held by the Police spéciale de roulage (PSR), Special Haulage Police, in Bujumbura.

Nathanael Biserere is not, as first thought, accused of having been involved in the attack on the aircraft, but is held on suspicion of having collaborated with soldiers from a military camp north of Bujumbura to sell ammunition from the camp to the armed opposition. He is held at the *Brigade spéciale de recherche* (BSR), Gendarmerie special investigation unit, in Bujumbura, where detainees are routinely ill-treated and tortured. A number of soldiers from the Muzinda military camp, Bubanza province, with whom he is supposed to have collaborated, have reportedly also been arrested. No information is available on their identities, whereabouts or well-being.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/ airmail letters in French or in your own language (please check that postal services are operating to Burundi from your country):

- calling for guarantees that all those detained will be protected from torture or cruel, inhuman or degrading treatment;
- seeking assurances that they have access to humanitarian and human rights organizations, lawyers and members of their families;
- calling for the detainees to be released if they are not to be charged with a recognized criminal offence for which there is substantiating evidence;

- asking for information about the soldiers, who were reportedly arrested along with Nathanael Biserere, and asking that their identities and whereabouts are made public.
