Amnesty International is extremely concerned for the safety of those listed above, amid reports that they are being severely tortured and that one of them, André Ndereyimana, is close to death. They have been in detention since they were arbitrarily arrested at the end of May 1994, are currently being held in Gitega prison in central Burundi. They are all civil servants.

The arrests were carried out, mostly at night, between 26 May and 1 June in Karuzi and Gitega provinces in central Burundi, by members of the security forces. Phillipe Kambayeko was reportedly dragged along the ground at the time of his arrest, with his hands and legs tied. Abraham Nibizi was arrested in the capital, Bujumbura.

Although no charges have been announced against the detainees, it appears they are suspected of involvement in the mass killings which occurred in late 1993.

A commission of inquiry to establish responsibility for the killings was opened by Burundi's Procuracy in April under government orders. It is not clear whether the commission or the Procuracy's Criminal Investigation Police ordered these arrests.

BACKGROUND INFORMATION

Violence engulfed most of Burundi in the aftermath of an attempted coup in October 1993 during which the country's first democratically elected president, Melchior Ndadaye, was killed by the soldiers. Between October and December 1993, up to 100,000 people wre killed. Many Hutu civilians were extrajudicially executed by the security forces (dominated by the Tutsi ethnic group), some of them in reprisal for the killing of Tutsi by Hutu gangs. Although much of the violence had abated by the end of 1993, sporadic killings of Hutu by members of the security forces and between armed Hutu and armed Tutsi civilians have continued. Burundi society has become severely polarised as a result of the killing.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in French/Kiswahili/English or in your own language:

- expressing concern at reports that some of the people named above (naming some) arrested between 26 May and 1 June 1994 have been subjected to severe beatings and other forms of torture or cruel, inhuman or degrading treatment, both at the time of their arrest and in detention in Gitega;

- urging the authorities to ensure that they will not be subjected to any further torture or ill-treatment and that they will be allowed immediate access to medical care;
- urging the authorities to investigate the reports of torture and other forms of ill-treatment with a view to bringing those responsible to justice, as required by the UN Convention against Torture ratified by Burundi in 1993; expressing concern that the detainees appear to have been subjected to arbitrary arrest, and asking to be informed of what charges are to be brought against them, and urging that they be immediately released if they are not to be promptly charged with a recognizably criminal offence.
