UA 190/99Fear of further extrajudicial executions in Kanyosha commune, Rural Bujumbura and Bujumbura 29 July 1999

BURUNDIAt least 30 unarmed civilians including: Raphaël, aged 8

Emmanuel, aged 10 Spès, aged 11 Anatole, aged 9 Bizimana, aged 5 Bosco, aged 7

In the last two weeks at least 30 unarmed civilians are reported to have been killed by soldiers in the capital Bujumbura and the surrounding province of Rural Bujumbura. The killings have reportedly taken place during or after a recent escalation of military operations in the area. Amnesty International is concerned that further civilians may be killed as the operations continue.

On 17 July 1999 around 40 cows were stolen from a military position in Kinindo, Bujumbura, reportedly by members of armed opposition groups located in Rural Bujumbura. Since then there have been an increased number of military operations, both to find members of the opposition and to retrieve the cows.

On 18 July, at least five and possibly as many as 12 unarmed civilians were killed in Musaga zone, Bujumbura. Soldiers reportedly accused them of failing to prevent the theft of the cows. At least five people were reportedly burnt in a house.

On or around 19 July, soldiers from two military posts surrounded houses in Gisovu colline (administrative unit), Kanyosha commune and shot up to 27 people, including the 6 children named above. The killings apparently took place as people were getting ready to go to work. Most of those killed were reportedly shot at close range. Soldiers are also reported to have looted the area later that day and to have burnt down scores of houses.

On or around 20 July, soldiers reportedly forced women and children in Ruziba, Kanyosha commune, to accompany them on a military operation to look for members of the armed opposition. It is not known whether there were any casualties.

On 26 July, two women were reportedly shot dead by soldiers in Kinuke, Kanyosha commune as they worked in their fields. The population of Kinuke had been evacuated to Ruyaga, Kanyosha commune because of conflict. The women were apparently shot because they had returned to their fields without the authorisation of the soldiers at Ruyaga.

On 29 July, the Governor of Rural Bujumbura told Amnesty International that reports of killings in Gisovu were not correct and that there was no need for an investigation.

BACKGROUND INFORMATION

Since November 1998, there has been intense activity by armed opposition groups in Burundi, particularly in the province of Rural Bujumbura and the southern provinces of Makamba and Bururi. The targets have been both military and civilian. Reprisals by the armed forces have been brutal and indiscriminate. At least 600 unarmed civilians are reported to have been killed by the armed forces in Rural Bujumbura since then. They appear to be almost exclusively extrajudicial executions as acts of reprisal by the security forces. Virtually

none of the killings have been the subject of impartial independent investigations.

RECOMMENDED ACTION: Please send telegrams/faxes/letters in French or your own language (please check with your post office whether post is being delivered to Burundi):

- expressing concern at reports of a series of extrajudicial executions in Rural Bujumbura and Bujumbura town (give details);
- calling for immediate steps to be taken to protect unarmed civilians from extrajudicial executions;
- calling for investigations into the reports of extrajudicial executions, and those responsible for any human rights violations to be brought to justice.
