## BURUNDIEmile MASABO

It has been confirmed that Emile Masabo, who "disappeared" after being taken into military custody, is been held in detention cells (cachots) at the local administration in the village of Mubone in Mutimbuzi commune, close to the capital, Bujumbura. He has not been charged and Amnesty International continues to be concerned about his safety.

Emile Masabo had initially been arrested on 16 March in Maramvya sector, Mutimbuzi commune and transferred to a military camp in northern Burundi. On or around 28 March, he was told he was being released. He was brought to Bujumbura, but rather than being released, he was once more taken into custody. He had not been seen since, and attempts to establish his whereabouts had been unsuccessful.

## FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French or in your own language (please check that postal services are operating to Burundi from your own country):

- welcoming that the authorities have acknowledged Emile Masabo's detention and confirmed his whereabouts;
- calling for him to be granted immediate access to family, lawyers, medical care and humanitarian and human rights organizations;
- asking to be informed of the basis for his continued detention, and urging that he be immediately released, if he is not to be charged with a recognizably criminal offence for which there is substantiating evidence;
- calling on the authorities to take urgent measures to ensure members of the armed forces respect arrest and detention procedures, and to bring to justice those found to have tortured or extrajudicially executed detainees in their custody.
