Further Information on UA 12/03 (AFR 25/001/2003, 10 January 2003) "Disappearance" / excessive use of force / impunity / detention without charge new concern: Possible prisoners of conscience

ETHIOPIA

Detained members of the Lideta church

Released: Daniel Zerfu (m), church deacon

Daniel Zerfu is now believed to have been released from police custody, though it is not known whether he faces any charges. He was reportedly severely beaten following his arrest on 27 December 2002 and was treated at the police hospital in the capital Addis Ababa.

Some members of the Ethiopian Orthodox Lideta church detained by the Federal Police Special Force on 27 December, in connection with the dispute over the appointment of the new Lideta church leader, are still believed to be in detention and may be prisoners of conscience. Some of the protesters are alleged to have been tortured or ill-treated and Amnesty International remains concerned for their safety. Those arrested earlier in November have reportedly been provisionally released - no date has been set for their trial.

Please note that Lideta church is in Addis Ababa, **not** in Mekele, capital of Tigray region, as stated in the original UA.

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English or your own language:

- noting the release of Daniel Zerfu, but calling on the authorities to launch a full and impartial investigation into allegations of ill-treatment by members of the Federal Police Special Force;
- calling for those responsible for his ill-treatment to be immediately suspended and brought to justice;
- urging the authorities to either charge or immediately release members of the Lideta church who were detained on 27 December 2002 and may be prisoners of conscience;
- calling for any remaining detainees to have immediate access to a lawyer, their families and any medical assistance they may require;
- urging the authorities to send a clear message to members of the Federal Police Special Force that the excessive use of force against peaceful protesters will not be tolerated.
