DISAPPEARANCE: Mesfin Shifferaw

Twelve publishers and journalists from new independent magazines, arrested in January/February 1994, have been provisionally released. Some of them were reportedly charged with offences against the Press Law (1992) and released on bail, while others were provisionally released without having been formally charged.

Six others still remain in prison:

Tefera Asmare (editor of *Ethiopis* magazine) was sentenced to two years' imprisonment on 25 March on account of two articles he published. He is due back in court soon to face a third charge. Daniel Kifle, Daniel Tadesse and Girmay Gebre-Tsadik are still in police custody but it is not clear if they have been formally charged. Meleskachew Amha and Berehane Mewa (who is also a prominent businessman and chairman of the Ethiopian Chemical Association) were provisionally released in early March. They were immediately re-arrested apparently in connection with an article they published in *Dewol* and *Alef* magazines containing a statement by a hitherto unknown group, the *Ethiopian Unity Brigade*, which claimed responsibility for an attack on a US diplomat in March.

Six more journalists have been recently arrested, bringing to 12 the total number of journalists currently in detention for political offences:

Kefale Mammo, chairman of the Ethiopian Free Press Journalists Association and editor-in-chief of *Ruh* magazine was arrested on 7 April and has not been formally charged: the real reason for his arrest may be his campaigning for the release of the journalists and for the freedom of the press in Ethiopia, and for contacting international media organizations.

Tenker Tedla, Belanyeh Alegu and Feleke Alemu of Mekdela magazine were arrested on 10 March and have not been formally charged. Wolde-Ghiorgis Wolde-Michael of Muday magazine was arrested on 17 March and has not been formally charged. Kassa Keraga of Ye Igziabeher Mengist ("Kingdom of God") religious magazine was arrested in February, fined for insulting Islam, and is serving a two-year prison sentence on account of being unable to pay the fine. Six independent magazines, including Ruh and Muday, have been forced to close.

There is no new information about another journalist, **Mesfin Shifferaw**, editor of *Twaf* magazine, who has been missing since 11 February 1994. He is a diabetic and requires regular medication. The authorities have said that he was not arrested. Fears continue to be expressed that he may be detained in secret, although Amnesty International has not been given any evidence to confirm this and is continuing its investigations.

RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express and airmail letters either in English or in your own language:

- expressing concern at the arrest of Kefale Mammo, chairman of the Ethiopian Free Press Journalists Association, who had criticised repression of journalists in Ethiopia and had earlier been questioned about articles he had published criticising the government;
- expressing concern about continuing arrests and detentions of journalists, including the sentencing of Tefera Asmare and Kassa Keraga to prison terms, on account of articles they published which did not advocate violence;
- requesting a full investigation by the authorities into the disappearance of Mesfin Shifferaw;
- appealing for the immediate release of these journalists as prisoners of conscience and withdrawal of all charges relating to their professional journalism.
