In January 1992 the Rwandese Minister of Foreign Affairs sent to Amnesty International a report of a commission of inquiry set up by, and composed of officials from the Rwandese Ministry of the Interior and Communal Development. The report concerned, among other human rights issues, the arrest of the 11 people mentioned above. These 11 were arrested between 20 and 22 October 1991 in Nyamata, Kanzenze commune (district), Bugesera Sous-préfecture (administrative sub-region) in Kigali préfecture (administrative region) on the orders of local government officials. The report confirmed that they are still held at Kanzenze district headquarters.

Concerning these arrests, the report said that the 11 were arrested in connection with the recruitment of youths in Bugesera to join the rebel group known as the Front patriotique rwandais (FPR), Rwandese Patriotic Front, which has been fighting a guerilla war against government forces since October 1990. The report claimed that the detainees' cases are being handled by the Procuracy at Nyamata. It did not mention whether they had been charged with specific offences and whether or when they would be brought to trial. It said that the detainees had not been beaten and that they freely confessed that they had intended to join the ranks of the FPR. It continued to say that Gisagara and Mushimire had made defamatory remarks about President Juvénal Habyarimana, without specifying what those remarks were.

In a related development the administrator (Bourgmestre) of Kanzenze commune imposed fines on Harelimana, Musoni and Mutambuka solely because they had been found in the company of people not normally resident in the area suspected of wanting to join the FPR. This was evidently a violation of both their right to freedom of association and their right to have their cases heard by an independent judicial authority.

FURTHER RECOMMENDED ACTION: Telegrams/telexes/faxes/express and airmail letters in

## FRENCH, if possible:

- welcoming the decision by the officials of the Ministry of Interior and Communal Development to carry out an investigation into the arrest of the 11 people (naming some or all of them) mentioned above and asking if the report has been made public;
- asking if they are still held and, if so, whether they have been charged with specific offences;
- asking the authorities to give details of the defamatory remarks made by Gisagara and Mushimire and expressing concern that if the remarks do not advocate the use of violence then the two persons may be prisoners of conscience who should be released without delay;

- seeking assurances that the 11 detainees can challenge the reasons for their detention in a court of law which should also order an independent investigation into the claim by the inquiry that they were not subjected to ill-treatment;
- urging the authorities to release all 11 immediately unless they have been charged with recognizably criminal offences and are to be promptly brought to trial.
