SIERRA LEONE: 264 political detainees at the Central Prison, Pademba Road, Freetown, including:

Bockarie Babay, farmer

Alhaji Kallon, school student, aged 14

Finda Mbriwa, housewife

Sahid Mohamed Sesay, student

On 12 November 1993 154 political detainees were released from the Central Prison, Pademba Road, in Freetown. According to official figures, a total of 240 political detainees have been released since July 1993. Amnesty International believes that almost all of the political detainees seen by its representatives when they visited Pademba Road Prison in early May 1993 have now been released.

Among those released on 12 November was Alhaji Kallon, a 14-year-old school student, who had been held since August 1992. Sahid Mohamed Sesay, however, is among the few who remain held without charge or trial. A law student at Fourah Bay College in Freetown, Sahid Mohamed Sesay was arrested in December 1992 in connection with an alleged coup attempt and has now been held for a year without charge or trial. Eight prison officers, also held since December 1992 in connection with the alleged coup plot, were released from the Criminal Investigation Department (CID) headquarters in Freetown on 11 November 1993.

Amnesty International welcomes the recent releases of political detainees, but is concerned that a few are still held without any opportunity to challenge their continued detention in a court of law.

BACKGROUND INFORMATION

At the end of November 1993 Captain Valentine Strasser, who came to power following a coup in April 1992, announced details of a transition program leading to civilian rule in early 1996. He also announced a unilateral cease-fire with effect from 1 December 1993. Government troops fighting rebel forces in the south and east of the country since 1991 have retaken most of the areas previously held by the rebels.

FURTHER RECOMMENDED ACTION: Please send express and airmail letters in English or your own language:

- welcoming the release of a further 154 political detainees from Pademba Road Prison on 12 November 1993;
- expressing the hope that these latest releases represent a move towards an

end to long-term detention without trial;

- expressing concern, however, that Sahid Mohamed Sesay remains detained without charge or trial, a year after his arrest;
- urging that he and any other political detainees who are still held at Pademba Road Prison be released unless they are to be charged and promptly brought to trial.
