Amnesty International is concerned for the safety of the six people named above. The circumstances surrounding their arrest suggest that they may be prisoners of conscience.

They and several other prominent people were arrested between 27 and 29 January 1998 in Bukavu, the capital of South-Kivu province, eastern Democratic Republic of Congo (DRC). Désiré Rugemaninzi, Engineer Mushegera and Cubaka are being held by the Agence nationale de renseignements (ANR), National Intelligence Agency, security service in Bukavu. Espoir Ruhigita Bulangalire, Augustin Babunga and Masu Ga Rugamika were transferred to the capital, Kinshasa. They are thought to be held by the ANR but the authorities have not revealed their whereabouts. Pierre Ndatabaye, chief of Ngweshe, and Kamola Muderhwa are reported to have been released in unclear circumstances a few days after their arrest.

The ANR is notorious for ill-treating detainees, including subjecting people to electric shock. Those who have been transferred to Kinshasa will be effectively denied access to their relatives. Detainees in the DRC usually depend on their relatives for food.

The detainees were reportedly arrested after a meeting in Bukavu with President Laurent-Désiré Kabila. President Kabila and several government officials were returning from a visit to neighbouring Uganda. Those arrested are reported to have expressed concern to President Kabila about human rights violations and destruction of private property by government forces in the context of operations against armed government opponents. They appear to have been targeted because they were prominent members of the society in South-Kivu.

Désiré Rugemaninzi is a traditional chief of Kabare chefferie, while Masu Ga Rugamika is rector of the Université libre des pays des Grands lacs (ULPGL), Free University of the Great Lakes Countries, in Goma. Espoir Ruhigita Bulangalire and Augustin Babunga are lecturers at the Université évangélique en Afrique (UEA), Evangelical University in Africa. Engineer Mushegera works for a German government-funded development organization known as Gesellschaft für Technische Zusammenarbeit (GTZ), Society for Technical Cooperation. Cubaka was until recently manager of Riviera hotel in Bukavu which belongs to former Prime Minister Faustin Birindwa. The authorities reportedly ordered their arrest after accusing them of supporting armed government opponents locally known as Mayi-Mayi.

## BACKGROUND INFORMATION

Since it came to power in May 1997, the AFDL government has committed numerous human rights abuses against critics of the government and representatives of civil society, including church leaders. Hundreds of people are reported to have been arrested. Furthermore, dozens of people have "disappeared" or have been extrajudicially executed.

## RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French, English, Kiswahili or your own language:

- expressing concern at reports that the six men were arrested solely because they expressed their views, including about human rights violations by government forces;
- seeking assurances that the detainees are protected from any form of ill-treatment and that they are allowed regular access to their relatives, legal counsel and independent medical care;
- calling for their immediate release unless they have been charged with a recognizable criminal offence and given an opportunity to challenge the basis for their arrest before a competent, independent and impartial judicial official.
