**Further information on UA 159/02 (AFR 62/008/2002, 30 May 2002) -
"Disappearance" / fear of torture or ill-treatment New Concerns: Prisoner of
Conscience/Medical Concern**

Kikandi Shandwe and Bernard Bafulwa Baranga were released without charge on 31 May. Zélate Farini is currently in detention, accused of taking part in a March 2002 grenade attack in Goma. The three men were feared "disappeared" on 27 May following a wave of arrests by the authorities.

Amnesty International is also concerned for two other men arrested at around the same time and who remain in detention. Djento Mahungu is a prisoner of conscience, whilst Simon Salumu requires urgent medical attention.

The two released men and Zélate Farini were held in a private house in Goma occupied by Rwandese Patriotic Army (RPA) officers. They were kept blindfolded and their arms tightly bound behind their backs throughout their detention, causing them excruciating pain. They were also made to sleep in the open, outside the house at night.

On 31 May the three men were presented at a "press conference" organized by the *Rassemblement congolais pour la démocratie - Goma* (RCD-Goma), Congolese Rally for Democracy, a Rwandese-backed armed opposition group and *de facto* authority in the region. At the conference Zélate Farini made statements incriminating himself in the grenade attack. Local sources believe he may have made these statements under duress. Kikandi Shandwe and Bernard Bafulwa were released after the press conference.

Djento Mahungu, a *chargé de relations publiques*, spokesperson, for Goma civil society, was arrested on 30 May. His arrest is believed to have been prompted by an interview he gave to international radio networks on the tense situation and series of arrests in Goma. Amnesty International believes he is a prisoner of conscience. He is detained at the G2, a division of the RCD-Goma military headquarters. Local human rights activists have been refused permission to see him.

Simon Salumu, a trader from Sake, near Goma, was arrested on 29 May by RPA soldiers. He is accused of being involved with an armed political group, the *mayi-mayi*, opposed to the RCD-Goma and to the Rwandese presence in the region. Witnesses report that he was badly beaten at the time of his arrest, including by being thrashed with *cordelettes*, military belts.

A relative who was able to see him in detention in Goma reported that he was in a poor state of health. He is detained at the *Direction générale de sécurité* (DGS), General Directorate for Security, in Goma. Amnesty International believes that he may be in urgent need of medical attention.

FURTHER RECOMMENDED ACTION: Please send appeals in English or French or in your own language:

- welcoming the release of Kikandi Shandwe and Bernard Bafulwa Baranga;

- calling for the immediate and unconditional release of Djento Mahungu, unless he is to be charged with a recognizably criminal offence for which there is supporting evidence;
- calling for Simon Salumu to be given access to immediate medical attention, following reports that he was severely ill-treated at the time of his arrest;
- calling for assurances that Djento Mahungu, Simon Salumu and Zélote Farini will be protected from ill-treatment or torture while in detention;
- calling for the men to be given immediate access to human rights and humanitarian organizations, to visits by family members and legal representatives;
- calling for clarification of the charges and supporting evidence against all three men;
- demanding that those alleged to have ill-treated the detainees be brought to justice before an independent and impartial court of law.
