Six of the seven people held unlawfully by a Rwandese-backed armed opposition group have been released without charge.

Gervais Chirhalwira Nkunzimana, Paulin Bapolisi, Aloys Muzalia Wakyebwa and Régine Mutijima were released without charge on 29 September after being detained for several days in the northeastern town of Kisangani. The four civil society activists had been arrested on 29 August in Bukavu, in the eastern part of the Democratic Republic of Congo (DRC), by the armed opposition group the Rassemblement congolais pour la démocratie - Goma (RCD-Goma), Congolese Rally for Democracy. There are no reports that they were ill-treated.

Dr Safari wa Karume and his brother Lusambo wa Karume were released without charge on 9 September. They had been arrested in Rwanda on 3 August and were later transferred to Bukavu. Lusambo wa Karume is a diabetic, and Dr Safari wa Karume was on his way to Nairobi for a medical check-up when arrested. Their health deteriorated as a consequence of their detention, and both need continuing medical treatment. RCD-Goma have not said why they were arrested.

Bonheur Badesire Isungu continues to be detained in Kalemie, a town in southeastern DRC. He has reportedly been severely ill-treated in custody. He was arrested in Bukavu on 5 June and is accused of having links with local armed groups known as <code>Mayi-Mayi</code>, who are opposed to RCD-Goma.

RCD-Goma, which controls parts of eastern DRC, is supported by the government of Rwanda, and the Rwandese security forces were involved in all of the above arrests. Amnesty International believes that the Rwandese authorities can secure the release of people detained by RCD-Goma, including Bonheur Badesire Isungu.

FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in French or English or in your own language:

- welcoming the release of the six people named above by the RCD-Goma, but expressing concern that the arrests were arbitrary, and that Dr Safari wa Karume and Lusambo wa Karume are suffering health problems as a result of their detention;
- expressing concern at reports that Bonheur Badesire Isungu has been severely ill-treated in custody, and calling on the authorities to guarantee his safety, and to ensure that he receives any medical treatment he requires;

- urging that he is promptly returned to Bukavu, where he can be visited by his relatives, doctors, lawyers and human rights or humanitarian organisations; - urging his immediate and unconditional release if he is not to be charged with a recognizably criminal offence.
