## Anthropological and ethnological researchers working in Sangradouro indigenous territory

On 9 August, Hipăridi Top'tiro and members of the Xavante Warā Association were reportedly threatened again by the regional administrator of the National Indigenous Foundation (*Fundação Nacional do Indio, FUNAI*) in Primavera do Leste. Amnesty International is concerned for their safety.

The regional administrator of FUNAI allegedly has strong links to landowners in the region, and has been intimidating and threatening Hipãridi Top'tiro and his family for a long time.

According to reports, FUNAI's regional administrator stated to an indigenous leader at FUNAI's office in Primavera do Leste that "ninguém me tira daqui, porque tenho amigos poderosos: o governador de Mato Grosso, oito deputados e o próprio presidente da Funai. Hipãridi Top'tiro iria pagar caro por tê-lo denunciado à Anistia Internacional e que os dias do presidendente da Associação Xavante Warã estavam contados"; ("Nobody will throw me out because I have powerful friends; the Mato Grosso Governor, eight members of Parliament and the President of FUNAI. Hipãridi Top'tiro will pay dearly because he reported me to Amnesty International, and the days of the president of the Xavante Warã Association are numbered"). FUNAI's regional administrator also reportedly stated that he would tie up the feet and hands of Hipãridi Top'tiro and throw him into a dustbin; and that the staff of Xavante Warã Association should be careful because nobody treats him that way. Though Dr Mariana Ferreira was not explicitly threatened, she remains in danger through her association with Hipãridi Top'tiro.

The threats against Hipāridi Top'tiro and his family allegedly relate both to his work on *Salve o Cerrado* (Save the Sierra), an environmental project, and a legal action that he brought against local landowners for allegedly deforesting part of an indigenous area. Dr Ferreira, who works with Hipāridi Top'tiro on *Salve o Cerrado*, has reportedly received veiled death threats, and even what appear to be attempts on her life.

# FURTHER RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in English, Portuguese or your own language:

in the light of the new threats, expressing serious concern for the safety of Hipãridi Top'tiro, his family, Dr Mariana Ferreira and other anthropological and ethnological researchers working in Sangradouro indigenous reserve;
asking the authorities to investigate the new threats they have received and to bring those responsible to justice;

- calling on the authorities to provide federal protection, as deemed appropriate by those under threat, to guarantee their safety;

- expressing your concern that consistent reports of threatening behaviour by the regional administrator of FUNAI in Primavera do Leste have not been investigated;

- should these reports be verified, calling on the authorities to implement all appropriate disciplinary and legal sanctions to address threatening behaviour by the regional administrator of the FUNAI in Primavera do Leste.
