Further information on UA 252/99 (AMR 22/23/99, 27 September 1999) - Fear for safety / Death Threats

Amnesty International remains extremely concerned for the safety of Viviana Díaz, president of the non-governmental organisation *Agrupación de Familiares de Detenidos Desaparecidos*, Association of Relatives of the "Disappeared", who has received further death threats. Dora Carreño, a member of the organisation, has also received death threats.

On the morning of 5 October 1999 Viviana Díaz found a series of handwritten death threats in the front garden of her house: "*por poco tiempo más te va a durar la cuerda*" ("you won't last much longer"), "*Antes de que cante el gallo tu no estarás*" (by the time the cock crows you won't be around), "*andate con cuidado te queda poco*" (take care, your time is running out), "*bas [sic] a seguir camino la Zola [sic]*" ("you're going to follow in Sola's footsteps" - this seems to refer to the former president of the *Agrupación*, Sola Sierra, who died in July 1999), "*tienes tus días contados*" ("your days are numbered") and "*te queda poco*" ("your time is running out"). That night her private telephone line was interfered with and cut off intermittently over several hours.

On 6 October 1999 a judicial complaint about all the threats Viviana Díaz has received was filed before the Appeals Court in Santiago (*Corte de Apelaciones de Santiago*). The threats have been denounced before the Minister of the Interior and Viviana Díaz has been offered police protection.

Agrupación member Dora Carreño is reported to have received threatening telephone calls. Amnesty International believes that this is connected with her personal testimony before Judge Baltasar Garzón in the proceedings against former General Augusto Pinochet and others, currently underway in Spain, and the detention in Chile of former Air Force General Edgard Ceballos Jones in connection with the death as a result of torture of her father, Alfonso Carreño, and the "disappearance" of José Baeza Cruces.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or your own language:

- expressing concern at the death threats against Viviana Diaz and her family, and Dora Carreño;
- expressing continued concern about the threats against parliamentarians Ricardo Nuñez and José Antonio Viera-Gallo and their families;
- urging the authorities to effectively protect Viviana Díaz and Dora Carreño to enable them to continue their legitimate human rights work;
- calling for an immediate investigation into these threats, for the findings to be made public and for those responsible to be brought to justice.
