## UA 73/98 Fear for Safety/Possible "Disappearances"/Possible

## Fear for safety/Disappeared:

a young woman and four men, inhabitants of Pueblito Mejía, Municipality of Barranco de Loba, Department of Bolívar

There is serious concern for the safety of the inhabitants of the hamlet of Pueblito Mejía following an incursion by heavily armed men on 2 March 1998 during which two inhabitants were killed and other members of the community threatened. There is also concern for a young woman and four men abducted by the armed group whose whereabouts remain unknown.

According to information received, a group of approximately 300 heavily-armed men, identifying themselves as members of a paramilitary group, entered the community of Pueblito Mejía at 2:00am. Casimiro Soto Ardila and Omar Bello Martínez were seized and killed. At 7:00am the gunmen decapitated Casimiro Soto Ardila witnessed by the community which had been forced to assemble. Omar Bello was later shot to death. An eight-year-old boy was reportedly wounded in the shooting. Carlos Mejía and Ismael Canabate were also seized but later released.

The military incursion has reportedly resulted in approximately 100 families fleeing their homes and seeking shelter in the municipal capital Barranco de Loba.

This attack heightens concerns for the safety of the inhabitants of the municipality of Barranco de Loba and the neighbouring municipalities of Tiquisio, Morales and Río Viejo. Concerns are further heightened by the fact that the armed group reportedly stated to witnesses that their next targets were the communities of Buena Seña and Buena Vista in the municipalities of Río Viejo and Morales respectively. On 3 March the armed group was reported to be heading towards the community of Sudan in the municipality of Tiquisio.

Over the last year there have been a number of attacks in these municipalities and other municipalities of the south of Bolívar in which inhabitants considered to be guerrilla collaborators or sympathizers have been the victim of serious human rights violations committed by paramilitary groups operating in unison with the Colombian armed forces.

According to witnesses, the armed group was made up of a large number of armed men wearing Colombian army uniforms with the insignia of the *Batallón Nariño*, Nariño Battalion attached to the *Segunda Brigada*, Second Brigade.

# BACKGROUND INFORMATION

Members of the Colombian army and security forces, together with their paramilitary allies, continue to commit serious abuses with virtual impunity. Over the past five years, several thousand civilians have been killed by paramilitary groups throughout the country. Although in 1989 the Colombian government suspended the legal base for the formation of paramilitary organizations and issued directives to the Colombian armed forces to combat and disband such groups, paramilitary forces have continued to kill and "disappear" perceived opponents with impunity in many areas of the country

and continue to work with the support of the security forces. President Ernesto Samper Pizano has made repeated promises to improve the human rights situation and to dismantle paramilitary forces. However, no steps have been taken to control their actions and to hold members accountable for serious and widespread human rights violations.

# RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in SPANISH or your own language:

- expressing concern for the safety of the inhabitants of the municipality of Barranco de Loba following an armed incursion into the community of Pueblito Mejia on 2 March 1998 and in particular for the five people abducted and whose whereabouts remain unknown and also for inhabitants of the neighbouring municipalities of Tiquisio, Morales and Río Viejo;
- urging that all measures deemed appropriate by the inhabitants of these municipalities are undertaken to guarantee their safety;
- urging that full and impartial investigations into the apparent extrajudicial executions of Casimiro Soto Ardila and Omar Bello Martínez, the wounding of an eight-year-old boy are undertaken and the whereabouts of the five people abducted, that the results are made public and that those responsible are brought to justice;
- urging that if any of these five people is in detention, they be charged with a recognizable criminal offence or be released immediately;
- urging that if any of these five people is in detention that they should be guaranteed immediate access to lawyers; relatives and medical doctors;
- calling for immediate action to dismantle paramilitary groups operating in the area, in line with stated government policy, in order to ensure the safety of the civilian population;
- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in the area and urging that those members of the security forces responsible for supporting and participating in such groups be brought to justice.
