Jorge Salazar and Jairo Bedoya, the two human rights defenders still held hostage by paramilitary forces, were released on 18 February 1999. They had been held hostage, along with Claudia Tamayo and Olga Rodas, by the national paramilitary organization *Autodefensas Unidas de Colombia* (AUC), United Self-Defence Forces of Colombia. Claudia Tamayo and Olga Rodas were released on 8 February.

All four work for the *Instituto Popular de Capacitación* (IPC), Popular Training Institute, a long established and internationally respected non-governmental human rights organization specializing in research, popular education and peace promotion. They were abducted from the organisation's offices in Medellín, capital of Antioquia Department, on 28 January 1999.

On 1 February the head of AUC, Carlos Castaño, threatened all Colombian human rights defenders, saying: "We have respected the majority [of defenders]...even though we know who they are and where they are. But enough is enough!... We do not want to create panic in the NGOs, but we do call for a purge of guerrillas from said organizations, a call extended to the Human Rights Unit of the Attorney General's Office." ("*Aún así hemos respetado la gran mayoría, conociendo quienes son y dónde están. Basta ya!... No deseamos crear pánico al interior de las ONG, pero hacemos un llamado a que se depure de guerrilleros la composición de dicha organizaciones, llamado extensivo la Unidad de Derechos Humanos de la Fiscalía*").

Following the release of Jairo Bedoya and Jorge Salazar, the AUC reportedly issued a statement in which it once again accused the two men of being members of guerrilla organizations. Human rights defenders are frequently labelled guerilla auxiliaries or supporters by the armed forces and their paramilitary allies, in an attempt to undermine their work and present them as legitimate targets in the counter-insurgency war. IPC workers are therefore still at risk.

**FURTHER RECOMMENDED ACTION: Please send telegrams/telexes/faxes/express/airmail letters in SPANISH or in your own language:**

- condemning the abduction by the *Autodefensas Unidas de Colombia* (AUC), United Self-Defence Forces of Colombia, of Jairo Bedoya, Olga Rodas, Jorge Salazar and Claudia Tamayo, all of whom have now been released, from the offices of the *Instituto Popular de Capacitación* (IPC), Popular Training Institute, in Medellín, capital of Antioquia Department;
- expressing grave concern for the safety of IPC workers and all human rights defenders after the threats made by the AUC, and asking for improved protection in line with United Nations recommendations and government commitments;
- expressing concern that the recent abduction and killing of Colombian human rights defenders demonstrate that government steps to protect them are insufficient and ineffective;

- saying that human rights defenders will continue to be the targets of attacks by paramilitaries unless effective action is taken to dismantle paramilitary groups in line with UN recommendations.
