Leaders of the Sindicato de Trabajadores de las Empresas Municipales de Cali (SINTRAEMCALI), Cali Trade Union of Municipal Service Workers have been followed and threatened by a man with possible links to paramilitaries. Amnesty International is concerned for their safety, and that of other trade unionists in Cali, Valle del Cauca department.

On 15 December at 4pm, SINTRAEMCALI leader Rubén Darío González, the trade union's human rights adviser Aydé Casilimas and their bodyguard Larry López, a member of the Departamento Administrativo de Seguridad (DAS), Civilian Intelligence Service, were travelling through Cali when they noticed a motorcyclist following their car closely. They tried to shake him off, and in the Petecuy district he crashed while trying to follow them round a sharp corner. They stopped in front of the motorcycle, and Larry López detained the rider. Whilst they waited for the police, the rider reportedly asked them: "Ustedes que prefieren a los paramilitares o a la guerrilla? Yo prefiero a los paramilitares", "Who do you prefer, the paramilitaries or the guerrillas? I prefer the paramilitaries". The police arrested the motorcyclist, but later released him.

SINTRAEMCALI trade union activists have received repeated paramilitary death threats and been victim of serious human rights violations in the last two years. In May two members of the union were killed by unidentified gunmen. Nobody is known to have been brought to justice for these killings, leaving SINTRAEMCALI at risk of further attack.

BACKGROUND INFORMATION

The security forces and their paramilitary allies have frequently accused trade unionists of being guerrillas collaborators, and followed up these accusations with serious human rights violations. At least 150 trade unionists have been killed so far this year, the majority by army-backed paramilitaries. A senior trade union leader, Wilson Borja Díaz, fled the country in December 2000 after he was shot and wounded by gunmen. Judicial investigations have linked the attack to several active and retired police officers (See UA 387/00, AMR 23/104/2000, 21 December 2000).

RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in Spanish, English or your own language:

- expressing concern for the safety of trade union leaders and activists with the SINTRAEMCALI union;
- asking the authorities what action they will take to guarantee the safety of those at risk,
- calling for a full and impartial investigation into previous human rights violations against members of the trade union with the results made public and those responsible brought to justice;

- calling for a full and impartial investigation into links between the security forces and paramilitary groups operating in Valle del Cauca Department, and asking that the results of the investigation are made public and those found responsible for supporting and participating in such groups are brought to justice;
- urging the authorities to take immediate action to dismantle paramilitary groups, in line with stated government commitments and recommendations made by the UN and other intergovernmental organizations.
